Rules and Regulations covering the filling of Nomination Paper:

1. The Nomination Paper must indicate the post being contested for.
2. The candidate proposer / seconder should give his/ her name in full in the place shown in the Nomination Paper.
3. A student can only propose or second, but not both.
4. A student contesting the election should not propose his/her own name.
5. A student is not entitled to propose or second more than one name amongst all the offices.
6. The candidate should put his/her signature wherever required mere initials will not do.
7. A candidate is entitled to file maximum of three nomination papers for a particular post.
8. Nomination papers will be rejected in case the entries made are wrong, disfigured or in case of any over-writing.
9. The nomination paper is liable to be rejected if any of the above-mentioned clauses is violated.
10. That any misrepresentation / concealment of facts will entail cancellation of the Nomination Papers.
11. President shall be elected from amongst the IIIrd year students or from among the students of Post Graduate classes.
12. Vice President and Secretary shall be elected from among the students of all classes.
13. Joint Secretary shall be elected from among the students of First year classes only.
14. The post of Vice President is reserved for female students only.
