

AMENDMENT NO. 1 TO THE MEMORANDUM OF UNDERSTANDING (MOU)
BETWEEN TRANSLATIONAL HEALTH SCIENCE AND TECHNOLOGY

This Amendment No. 1 is dated 5th August, 2023 (the "effective date") by and between the TRANSLATIONAL HEALTH SCIENCE AND TECHNOLOGY INSTITUTE, having its office located at NCR Biotech Science Cluster, 3rd milestone, Gurgaon-Faridabad Expressway, Faridabad-121001, Haryana, India, is an autonomous institute of Department of Biotechnology (DBT), Ministry of Science & Technology, Government of India (hereinafter referred to as "THSTI")

AND

RAM LAL ANAND COLLEGE located at Benito Juarez Marg, South Campus, South Moti Bagh, New Delhi - 110021 is a constituent college of the University of Delhi (hereinafter referred to as "Ram Lal Anand College")

WHEREAS, THSTI and Ram Lal Anand College entered into an MoU dated as of 5th August, 2020 (the "MoU") for implementing the Science Setu programme in colleges as mentioned in the MoU.



AND
