#### Introduction

Ram Lal Anand College, a distinguished institution under the University of Delhi, located at 5, Benito Juarez Road, New Delhi, invites Expression of Interest (EOI) from eligible Structural Auditors/Engineers empaneled with MCD (Municipal Corporation of Delhi). This EOI is also welcome from structural auditors of DTU (Delhi Technological University), IIT, Delhi; Engineering colleges under I P University and other AICTE recognised Engineering colleges/Universities in Delhi NCR. The objective is to conduct a detailed structural safety audit of the college buildings aimed at ensuring and enhancing its structural safety particularly in the context of seismic compliance, to ensure safety of users in case of an earthquake.

## Scope of Work

## 1. Structural Safety Assessment:

Evaluate the seismic vulnerability and resilience of the college building, focusing on the following primary partitions:

- Library Block
- · Administrative Block
- Academic Block
- · Sports Administration Block
- Auditorium Block

#### 2. Detailed Audit and Analysis:

- Conduct a comprehensive inspection of structural elements including foundations, beams, columns, and load-bearing walls.
- Assess the adequacy of structural design and construction materials in accordance with seismic codes and standards.

- Identify potential vulnerabilities and recommend measures for seismic retrofitting and strengthening wherever necessary.
- Evaluate the condition and functionality of building components such as roofing, flooring, walls, and drainage systems.

## 3. Feasibility Constraints Consideration:

- Recognise and address feasibility constraints that may arise from the age and historical significance of the building.
- Propose pragmatic solutions that balance safety requirements with the practical limitations inherent in retrofitting older structures with prevalent seismic codes and norms.

## 4. Plan of Action and Implementation:

- Develop a detailed plan outlining the methodology, approach, and tools for conducting the structural audit.
- Provide a clear timeline for completing the audit, submitting reports, and implementing recommended measures.
- Specify roles, responsibilities, and coordination requirements among stakeholders involved in the audit and subsequent actions.

## 5. Infrastructure Requirements:

- Specify any specialized equipment or tools required for seismic assessment and structural analysis.
- Outline logistical requirements for accessing and inspecting different areas of the college building.

## **Submission Requirements:**

Interested auditors must submit their EOIs in sealed envelopes addressed to the Principal, Ram Lal Anand College, University of Delhi. The submission should include:

- Company profile highlighting relevant experience in structural audits and seismic assessments of educational and institutional buildings.
- Proof of empanelment with MCD or association with other Engineering Institutes as outlined earlier
- Proposed budget detailing costs associated with conducting the structural audit and safety assessment.
- · Timeline indicating the schedule for completing the audit and delivering the final report.
- Comprehensive plan of action and implementation strategy, including methodology and resources.
- · List of infrastructure and logistical requirements necessary for conducting the audit.
