Sealed Tenders are invited for the disposal of **old furniture, Iron, Wooden, and Misc. items** (8 to 10 Tons Approximately)- in the College Campus on "AS IS WHERE IS BASIS". With details of terms and conditions as under:-

#### Terms and Conditions:

1. Sealed Bid should be submitted in the name of Principal, Ram Lal Anand College, University of Delhi, Benito Juarez Road, New Delhi-I 10021, super scribed as 'Quotation for Scraps'.
2. The Bidder should clearly mention the valid GST No./PAN No.
3. The bidder can physically inspect the scrap till 7<sup>th</sup> May 2018 between 10:00 A.M. to 3:00 P.M. on any working day and after that day no inspection will be allowed.
4. Last date for submission of bid is 10<sup>th</sup> May 2018 till 1.00 P.M. The Bid must be submitted in the Dak Section of the College.
5. The tender will be opened on the same date/day at 2:00 P.M.
6. The Tender will be offered to the highest bidder. Bids are invited for the lot. Incomplete Bid in any manner or submitted after due date would be summarily rejected. The college will not be responsible for any postal delay or delay because of whatsoever reasons may be.
7. The successful bidder must deposit the full and final amount of the bid before carrying the scrap out of the college premises. The amount has to be deposited in the form of a NEFT/Demand Draft drawn in favour of Principal, Ram Lal Anand College, as full and final payment
8. The successful bidder will be required to lift and clear all the items from the scrap site within four days of the payment of bid amount. On failing to do so the college will have full right to forfeit the entire amount of bidder and dispose the items to alternate bidder.
9. Bidder is responsible for labour charges such as for weighing, packing, loading and transportation for lifting the disposed items.
10. The college reserves the right to (i) Discontinue/terminate the process at any stage without being liable to any one and assigning any reason; (ii) And Exclude the party from any consideration if the documents/information is not provided as required or incomplete or lacking or the college has sufficient ground that it can go against the college interests at any stage; and (iii) Take the appropriate steps action as warranted from time to time if not satisfied with the weighing and loading as per rules in the interest of the college.
